## 1. Windows Server 2025 Standard Licensing Cheatsheet

# 2. How to Identify & Validate That Licensed Windows Server 2025 Standard Is Complete and Legal

- Purchase from Authorized Resellers: Buy from reputable vendors like Sniffton
   Technologies (P) Ltd. or other Microsoft-authorized partners to ensure legitimacy.
- Verify License Key: Ensure the product key is a 25-character code (e.g., XXXXX-XXXXX-XXXXX-XXXXX) provided upon purchase.

- Check Microsoft Volume Licensing Service Center (VLSC): For volume licenses,
   log into the VLSC to confirm the license is registered under your account.
- Activation Confirmation: Activate the server via the internet or phone and verify successful activation in the server's System settings.
- Certificate of Authenticity (COA): Look for a COA or digital license confirmation from the seller, indicating genuine Microsoft licensing.
- Cross-Check SKU/MPN: Match the SKU (e.g., DG7GMGF0PWHC:0003) and MPN (e.g., DG7GMGF0PWHC) with official Microsoft documentation.
- Avoid Suspicious Deals: Be cautious of unusually low prices or unofficial sources, which may indicate pirated or incomplete licenses.
- Microsoft Support Verification: Contact Microsoft support with the product key to confirm its validity if in doubt.

# 3. What Other Licenses You May Need Along with Windows Server 2025 Standard License

- Client Access Licenses (CALs): Required for each user or device accessing the server for basic services like file sharing or printing.
- Remote Desktop Services (RDS) CALs: Needed if users or devices access the server via Remote Desktop Services for remote desktop or application hosting.
- Windows Server CALs for Additional Features: Specialized CALs (e.g., Enterprise CALs) may be required for advanced features like Active Directory Rights Management Services.
- SQL Server Licenses: If running Microsoft SQL Server on Windows Server 2025, a separate SQL Server license is required (core-based or server + CAL).
- Exchange Server Licenses: For email and collaboration services, a separate Exchange Server license is needed if hosted on the server.
- Third-Party Software Licenses: Depending on applications (e.g., backup or antivirus software), additional licenses may be required.
- Microsoft 365 Licenses: For integration with Microsoft 365 services, additional user or device-based licenses may be necessary.

## 4. Who and Why You Might Need CALs and RDS CALs

Client Access Licenses (CALs)

- Who Needs Them: Any user or device accessing Windows Server 2025 for basic services like file storage, printing, or Active Directory authentication.
- Why They Are Needed: CALs are required by Microsoft's licensing model to ensure legal access to server resources for each user or device.
- Types: User CALs (one per user, ideal for employees with multiple devices) or Device CALs (one per device, ideal for shared devices like kiosks).
- **Use Case**: Essential for businesses with multiple users or devices accessing server resources, ensuring compliance with Microsoft's licensing terms.

### Remote Desktop Services (RDS) CALs

- Who Needs Them: Users or devices accessing the server via Remote Desktop Services to run applications or desktops remotely.
- Why They Are Needed: RDS CALs are required for any remote desktop or application hosting, in addition to standard CALs, to comply with Microsoft's licensing.
- Types: User RDS CALs (per user) or Device RDS CALs (per device), depending on the access model.
- **Use Case**: Ideal for businesses enabling remote work, virtual desktop infrastructure (VDI), or centralized application deployment.

# 5. If You Are Using It as a Web Server, Do You Still Need CALs or RDS CALs?

#### **CALs for Web Server Use**

- Not Required for Public Web Access: If Windows Server 2025 Standard is used as a
  web server hosting public-facing websites (e.g., via IIS), CALs are not required for
  anonymous users accessing the website over the internet.
- Required for Authenticated Access: If the web server requires user or device authentication (e.g., for internal users or restricted web apps), standard CALs are needed for each user or device accessing the server.
- **Example**: A public e-commerce site does not need CALs, but an intranet portal requiring employee login does.

#### **RDS CALs for Web Server Use**

Not Required for Web Server Functions: RDS CALs are not needed if the server is
only hosting web content via HTTP/HTTPS and not providing remote desktop or

application services.

- Required for Remote Desktop Access: If administrators or users access the server's desktop or applications remotely via Remote Desktop Services, RDS CALs are required in addition to standard CALs.
- **Example**: If you use Remote Desktop to manage the web server, RDS CALs are needed for those remote sessions.

**Key Consideration**: For web server scenarios, carefully assess whether your setup involves authenticated access or remote desktop usage to determine the need for CALs or RDS CALs. Purely public-facing web servers typically require only the Windows Server 2025 Standard license.
